The UK start up Visa class is for beginning period candidates for beginning a business in the UK for the first time and this visa class permits main candidate to work in the UK, alongside business to help themselves.

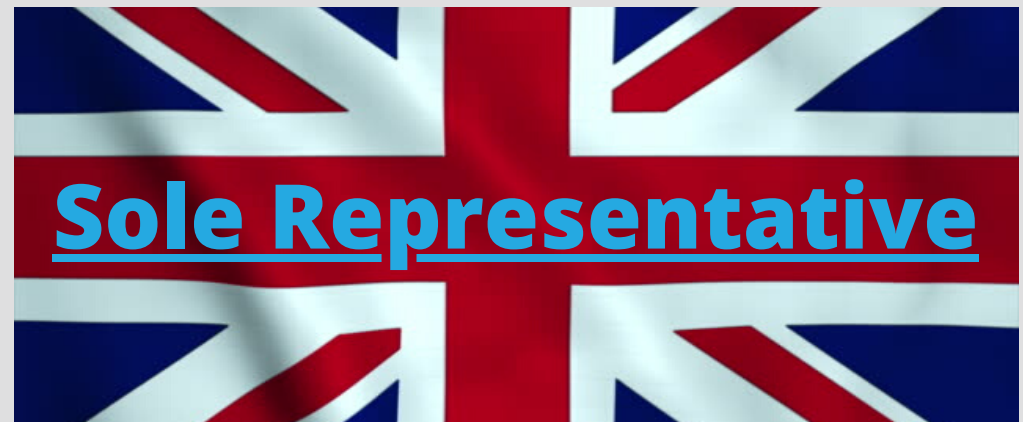
There is no age hindrance, education and profession restriction; to be qualified to apply under the UK Start up visa.



BENEFITS TO CHOOSE

Successful candidates are allowed residency for two years and can likewise bring their family members and kids under 18 to the UK.

Toward the finish of two years, Start up visa holders can broaden their stay by applying for Leave to Remain, permanent residency will be allowed following five years.

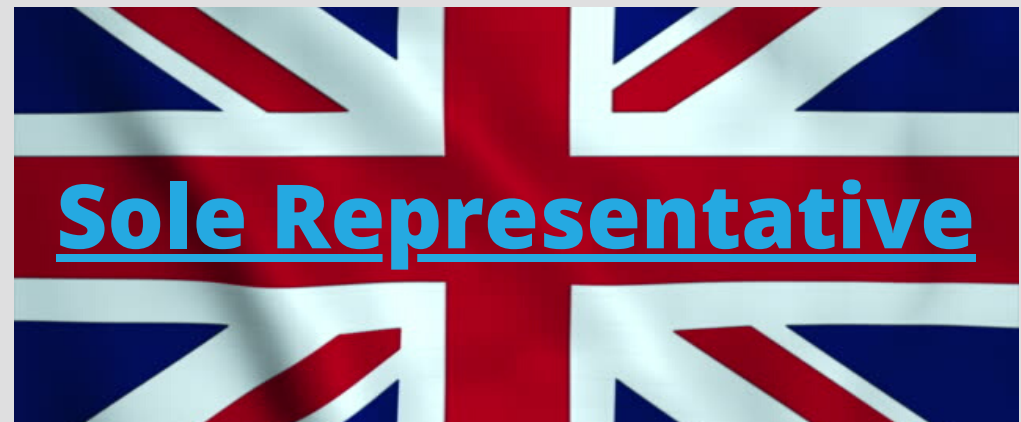


This category allows an individual usually a Senior Manager or a Senior Director to move to the UK to set up a branch or subsidiary on behalf of an overseas company.

The individual cannot be the majority shareholder, He or She must be a minority shareholder with a maximum share percentage of 49%.

The UK Sole Representative Visa is best suitable for those foreign companies who are well established and want to expand their business activity in the United Kingdom.

The most important requirement is that the parent company will fund the branch set up and also the expenses of the representative who is applying for visa to set up the branch in the UK.



BENEFITS TO CHOOSE

The minimum investment of GBP 50,000 is required to be done by parent company for the setup of their branch in the UK.

The initial visa will be given for 3 years and then it will be extended for further 2 years.

The ILR, Indefinite Leave to Remain will also be entitled to the family members and children below age of 18 years.

The Whole family for the representative will get benefits like free and highquality education for kids and Medical benefits for everyone.

The UK Innovator visa class is for experienced businessman or business people trying to set up a business in the UK.

In the case of Innovator visa, third party can be friends, family members, corporate bodies or investors.

Successful applicants will be granted residency for 3 years and they can also include their spouse/partner and children under 18.

After the successful completion of 3 years, applicant can apply for UK passport.
